Dear Applicant,

Thank you for your interest in attending the 2024 Northern Virginia Fire and Rescue Leadership Development Institute (LDI). The program will be held from October 14 – 19, 2024, at the National Conference Center (NCC) in Leesburg, Virginia.

LDI is an intensive one-week residential course designed to provide a foundation for newly promoted leaders and enhance the skills of experienced officers. Built upon core values and high expectations, this dynamic program sets a standard for high-performing officers throughout the fire service. Participants will learn about the art and science of direct and organizational leadership from world class instructors and will engage in the practical application of various management and leadership techniques.

This is a residential program, and students are required to stay overnight for the entire week. Daily physical training (PT) and adherence to a business casual dress code are mandatory. Expectations for all students will be outlined in a code of conduct, which requires strict adherence. Attendance at all classroom sessions, including evening programs, is mandatory. Students must complete pre-course reading and writing assignments by October 4, 2024. Further information about the pre-course assignments will be emailed to those accepted into the program.

When completing the application, please ensure all sections are filled out correctly. Incomplete applications will not be considered. Attach a properly formatted copy of your resume along with your completed application. The resume should be 1-2 pages long and formatted as follows:

1. Name and personal information (full name, address, email, phone)
2. Education
3. Work experience (positions held, volunteer/civic experience)
4. Organizational involvement/membership

Please complete the application using the link provided at the bottom of this page. The online application, including the student and sponsoring Fire Chief's signatures, must be submitted no later than August 1, 2024.

The tuition fee of \$2382.00 - \$2858.00 per student includes lodging and all meals for the entire week. Tuition will be invoiced to the student's sponsoring department upon acceptance.
